

General Treatment Consent Form

A **Facial Esthetique** clinical facial or body treatment may consist of surface cleansing, exfoliation, steam, extractions, corrective serum and mask application or wraps. Clinical treatments take approximately 30 minutes to one hour to complete and are designed to restore skin health and beauty as much as possible in the scheduled time.

Implements and equipment used in all **Facial Esthetique** procedures are disposable or properly sterilized according to the State Board Of Cosmetology regulations. Clinical therapists may wear surgical gloves, face mask and eye goggles throughout the entire procedure to ensure sterile techniques.

IMPORTANT: PLEASE READ CAREFULLY _____INITIAL

Use of Glycolic Acid and prescription Retinoids (Retin-A, Renova, Avita or Differin) 24 hours prior to a clinical facial may result in a more aggressive treatment. Alert your skin care specialist if you are using these products at home. Your skin care specialist may require you to discontinue use of these topicals 24 to 48 hours prior to and after the clinical facial treatment.

WARNINGS: PLEASE READ CAREFULLY _____INITIAL

1. Avoid direct sunlight following a clinical facial.
2. Wait 24 hours following a clinical facial before using Glycolic Acid and Retinoid products.
3. Avoid using scrubs or depilatories for 48 hours following the clinical facial.
4. Do not pick your skin following a clinical facial.
5. Avoid strenuous exercise for 24 hours following a clinical facial or body treatment.
6. If using Retinoid products do not have facial waxing.

I have informed my skin care specialist of any health problems of which I am aware, and all medications I am taking, particularly Accutane, Retinoids and topical prescription drug therapies. I understand that skin rejuvenation is best achieved through a series of recommended treatments and compliance to the home care product program recommended by a **Facial Esthetique** skin care therapist.

PRODUCT RETURN GUIDELINES _____INITIAL

Facial Esthetique cosmeceutical products are active formulas designed to treat skin conditions. Stimulating sensations are normal with product application but should not be painful. If a reaction should occur it would be necessary to make an appointment with your consulting Clinical skin care specialist prior to an exchange or return of any recommended products. All returns must be made within 15 days of purchase for exchange or spa credit only.

RESCHEDULING GUIDELINES _____INITIAL

A 24 hour rescheduling notice is appreciated and required. We realize emergencies happen and will be considered but reserve the right to charge a \$50.00 fee for missed appointments without a 24 hour notice. When booking spa packages a 50% deposit is required to reserve services and all deposits are non-refundable.
